INVITATION TO BID REPAIR/REHAB OF SAN ANTONIO CIS PB# MOMARO-017-A-2019

1. The NIA-MOMARO Irrigation Management Office, through the General Appropriation Act of CY 2019 intends to apply the sum of Two Million Seven Hundred Twenty Eight Thousand Three Hundred Twenty One Pesos & 12/100 (Php 2,728,321.12) being the Approved Budget for the Contract (ABC) to payments under the contract for REPAIR/REHAB OF SAN ANTONIO CIS with Contract No. MOMARO-ANTONIO-3.0M-CY19. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The NIA MOMARO IMO now invites bids for civil work contractor for the Construction of Canal Structures located at Sta. Cruz, Marinduque. Completion of the Works is required One Hundred Twenty (120) calendar days and the minimum equipment required are: one unit backhoe, one unit cargo truck, one unit dump truck, one unit bar cutter, one unit one bagger concrete mixer, and three units concrete cylinder (6" dia. X 12"). Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from NIA MOMARO IMO, Bids and Awards Committee and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM.
5. A complete set of Bidding Documents may be acquired by interested bidders on February 21, 2019 from the address below upon presentation of Letter of Intent (LOI) and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 5,000.00

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
6. The NIA MOMARO IMO will hold a Pre-Bid Conference on February 28, 2019; 10:00 AM at the Conference Room of NIA MOMARO IMO, Bayanan II, Calapan City, Or. Mindoro which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before March 12, 2019 at 10:00 AM. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

Bid opening shall be on March 12, 2019 at 10:01 AM. at the Conference Room of NIA MOMARO IMO, Bayanan II, Calapan City, Or. Mindoro Bids will be opened in the presence of the bidders (Managing Officer), no Special Power of Attorney (SPA), no Attorney-In-Fact Allowed to participate in the Bidding. Late bids shall not be accepted.

Bidder with negative 15% slippage of on-going projects will be automatically disqualified.
8. The NIA MOMARO IMO reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
