

**CONTRACT FOR BONGABONG RIP CY 2018 PACKAGE 4:  
CONSTRUCTION OF MAIN CANAL (STA. 4+060 – STA.5+926.80)  
INCLUDING SUPPLY, DELIVERY, INSTALLATION AND  
COMMISSIONING OF STEEL GATES AND ITS APPURTENANT  
STRUCTURES**

**THIS AGREEMENT**, made this 24<sup>th</sup> day of May, 2018 between THE GOVERNMENT OF THE PHILIPPINES, thru the NATIONAL IRRIGATION ADMINISTRATION MIMAROPA REGIONAL OFFICE, represented herein by the Regional Manager, WILLIAM P. RAGODON, with office address at Brgy. Bayanan II, Calapan City, Oriental Mindoro (hereinafter called the "Entity") and SIXTEEN ENTERPRISES represented by its General Manager, MARILOU F. MORILLO, with office address at Masipit, Calapan City, Oriental Mindoro (hereinafter called the "Contractor").

**WHEREAS**, the Entity is desirous that the Contractor execute for BONGABONG RIP CY 2018 PACKAGE 4: CONSTRUCTION OF MAIN CANAL (STA. 4+060 – STA.5+926.80) INCLUDING SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF STEEL GATES AND ITS APPURTENANT STRUCTURES (hereinafter called "the Works") and the Entity has accepted the Bid for TWENTY-EIGHT MILLION ONE HUNDRED FORTY-SIX THOUSAND EIGHT HUNDRED FOUR PESOS & 68/100 (Php 28,146,804.68) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

  - (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - (i) Eligibility requirements, documents and/or statements;
  - (j) Performance Security;
  - (k) Notice of Award of Contract and the Bidder's conforme thereto;
