CONTRACT AGREEMENT

THIS AGREEMENT, made this _____ day of JUL 23 2019 between THE GOVERNMENT OF THE PHILIPPINES, thru the NATIONAL IRRIGATION ADMINISTRATION MIMAROPA REGIONAL OFFICE, represented herein by the Regional Manager A, WILLIAM P. RAGODON, with office address at Bayanan II, Calapan City, Oriental Mindoro (hereinafter called the "Entity") and TWENTY SIXTEEN CONSTRUCTION & GENERAL MERCHANDISE, represented by its owner/manager, RICHARD V. INCIONG, with office address at San Isidro, Victoria, Oriental Mindoro (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute CONSTRUCTION OF CY 2019 BONGABONG RIP (PACKAGE 6 with Contract No. R4B-MMR-BRIP6-29M-CY19-10 (hereinafter called "the Works") and the Entity has accepted the Bid for TWENTY NINE MILLION FOUR HUNDRED SEVENTY ONE THOUSAND NINETEEN & 80/100 PESOS (Php 29,471,019.80) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - (i) Eligibility requirements, documents and/or statements;
 - (j) Performance Security;
 - (k) Notice of Award of Contract and the Bidder's conforme thereto;
