

CONTRACT FOR CONSTRUCTION OF MAUBOG SIP

MAY 24 2018

THIS AGREEMENT, made this _____ day of _____, 2018 between THE GOVERNMENT OF THE PHILIPPINES, thru the NATIONAL IRRIGATION ADMINISTRATION MIMAROPA REGIONAL OFFICE, represented herein by the Regional Manager, WILLIAM P. RAGODON, with office address at Brgy. Bayanan II, Calapan City, Oriental Mindoro (hereinafter called the "Entity") and POWER K CONSTRUCTION SUPPLY AND SERVICES represented by its Proprietor, KENNEDY T. HAW, with office address at Brgy. Aplaya , Pila, Laguna (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute CONSTRUCTION OF MAUBOG SIP (hereinafter called "the Works") and the Entity has accepted the Bid for THIRTY-FIVE MILLION ONE HUNDRED THIRTY-THREE THOUSAND NINE HUNDRED NINETY-SIX PESOS & 51/100 (Php 35,133,996.51) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as integral part of this Agreement, to wit:
 - (a) General and Special Conditions of Contract;
 - (b) Drawings/Plans;
 - (c) Specifications;
 - (d) Invitation to Bid;
 - (e) Instructions to Bidders;
 - (f) Bid Data Sheet;
 - (g) Addenda and/or Supplemental/Bid Bulletins, if any;
 - (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - (i) Eligibility requirements, documents and/or statements;
 - (j) Performance Security;
 - (k) Notice of Award of Contract and the Bidder's conforme thereto;
 - (l) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
