CONTRACT AGREEMENT

THIS AGREEMENT, made this MAR 06 2025 day of _____, 2025 between THE GOVERNMENT OF THE PHILIPPINES, thru the NATIONAL IRRIGATION ADMINISTRATION MIMAROPA REGIONAL OFFICE, represented herein by the Regional Manager, RONILIO M. CERVANTES, with office address at Bayanan II, Calapan City, Oriental Mindoro (hereinafter called the "Entity") and Showtec Audio and Lights Solutions Co., represented by its Attorney-in-Fact, **HERCULANO CONTANTE JR.**, with office address at 939 Aurora Blvd. corner Potsdam St., Cubao, Quezon City (hereinafter called the "Supplier").

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Supply and Delivery of IT Equipment, Software Installation and License Activation** with Contract No. **R4B-REGION-IT-1.6M-CY2024-018** (hereinafter called "the Works") and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **ONE MILLION FIVE HUNDRED NINETY-EIGHT THOUSAND FIFTY-FOUR PESOS (Php 1,598,054.00)** where completion is required within Thirty (30) calendar days from issuance of Notice to Proceed in the form of Purchase Order, including the remedying of any defects therein.


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial proposals, and all other documents or statements submitted;

In consideration for the sum of **ONE MILLION FIVE HUNDRED NINETY-EIGHT THOUSAND FIFTY-FOUR PESOS (Php 1,598,054.00)** or such other sums as may be ascertained, **Showtec Audio and Lights Solutions Co.** agrees to **SUPPLY AND DELIVERY OF IT EQUIPMENT, SOFTWARE INSTALLATION AND LICENSE ACTIVATION** in accordance with his/her/its Bid.
- 4. The NATIONAL IRRIGATION ADMINISTRATION MIMAROPA REGIONAL OFFICE agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


