THIS AGREEMENT, made this _____ day of _____, 2025 between **THE GOVERNMENT OF THE PHILIPPINES**, thru the **NATIONAL IRRIGATION ADMINISTRATION MIMAROPA REGIONAL OFFICE**, represented herein by the Regional Manager, RONILIO M. CERVANTES, with office address at Bayanan II, Calapan City, Oriental Mindoro (hereinafter called the "Entity") and **ASC Construction and Concrete Products**, represented by its General Manager, MR. ABRAHAM S. COLLADO, with office address at National Hi-way, Capatan, Tuguegarao City, Cagayan (hereinafter called the "Contractor");

WHEREAS, the Entity is desirous that the Contractor execute the contract entitled **ESTABLISHMENT OF PUMP IRRIGATION PROJECTS IN MAGSAYSAY, OCCIDENTAL MINDORO** with Contract No. R4B-REGION-OCCI2-1B-CY2025-003 (hereinafter called "the Works"), and the Entity has accepted the Bid for **ONE HUNDRED FORTY-FIVE MILLION ONE HUNDRED TWENTY-ONE THOUSAND ONE HUNDRED SEVENTY-FIVE & 32/100 PESOS (Php 145,121,175.32)** by the Contractor for the execution and completion of such Works within Two Hundred Ten (210) calendar days and the remedying of any defects therein;


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.



- b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial proposals, and all other documents or statements submitted;





4. The NATIONAL IRRIGATION ADMINISTRATION MIMAROPA REGIONAL OFFICE agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.






