### INVITATION TO BID

#### CONSTRUCTION OF MAG-ASAWANG TUBIG RIS (PACKAGE 1)

PB# MOMARO-021-2017

1. The NIA-MOMARO Irrigation Management Office, through the General Appropriation Act of CY 2017 intends to apply the sum TEN MILLION TWO HUNDRED SIXTY EIGHT THOUSAND ONE HUNDRED SIXTY FOUR PESOS AND 18/100 (Php10,268,164.18) being Approved Budget for Contract (ABC) to payments under the contract for Project with Contract No. MOMARO-MTRISP1-50M-CY17. Bids receive in excess of the ABC shall automatically rejected.
2. The NIA MOMARO IMO now invites bids for civil work contractor for the Construction of Diversion Works located at Victoria, Oriental Mindoro. Completion of work is required with two hundred ten (210) calendar days. Bidders should have an experience of having completed at least one (1) contract that is similar to the contract to bid, and whose value must be at least fifty percent (50%) of the ABC to be bid. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II, Instruction of Bidders.

Minimum Equipment Required:

- 1 unit of one-bagger Concrete Mixer
- 1 unit bar Cutter
- 1 unit Centrifugal Pump
- 1 unit of Cargo Truck
- 1 unit Backhoe

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulation (IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships or organization with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from NIA MOMARO IMO, Bids and Awards Committee at Barangay Bayanan II, Calapan City and issuance of the Bidding Documents starting March 10, 2017 from 8:00 AM to 5:00 PM.
5. A complete set of Bidding Documents may be purchased by interested Bidders starting March 10, 2017 at the Office address above upon presentation of Letter of Intent (LOI), renewed PCAB License with "Small B" in irrigation and Flood Control-AIC Certificate of Registration, Certificate of Site Inspection issued by the Office of Division Manager (MOMARO IMO) and upon payment of non-refundable fee of Twenty Five Thousand (Php 25,000.00) pesos to the Cashier.
6. A Pre-Bid Conference will be held on March 17, 2017, 10:00 AM at the Conference Room at the office address above, which shall be open only to all interested parties who have purchased the Bidding Documents.
7. Bids must be delivered to the above office address on or before March 28, 2017 11:00 AM. Bids will be opened on the same date at 11:01 AM at the NIA MOMARO IMO Conference Room. All bids must be accompanied by a bids security in any of the acceptable forms and in the amount stated in the ITB Clause 18.

Bids will be opened in the presence of the bidders (Managing Officer), no Special Power of Attorney (SPA), no Attorney-In-Fact Allowed to participate in the Bidding. Late bids shall not be accepted.

Bidder with negative 15% slippage of on-going projects will be automatically disqualified.

8. The NIA MOMARO IMO reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract of award, without thereby incurring any liabilities to the affected bidder or bidders, and not to award the contract if the funds/allotment for the project will be reduced/withheld or unforeseen event through no fault of NIA.
