## INVITATION TO BID MALIBAGO-MALUANLUAN PCIP PB# MOMARO-030-A-2017

1. The NIA-MOMARO Irrigation Management Office, through the General Appropriation Act of CY 2016 intends to apply the sum FOUR MILLION ONE HUNDRED FIFTY NINE THOUSAND EIGHT HUNDRED SEVENTY SIX PESOS AND 55/100 (Php4,159,876.55) being Approved Budget for Contract (ABC) to payments under the contract for Project with Contract No. MOMARO-MALPCIP-4.53M-CY17. Bids receive in excess of the ABC shall automatically rejected.
2. The NIA MOMARO IMO now invites bids for civil work contractor for the Canal Structures and other Facilities located at Pola, Oriental Mindoro. Completion of work is required with one hundred twenty (120) calendar days. Bidders should have an experience of having completed at least one (1) contract that is similar to the contract to bid, and whose value must be at least fifty percent (50%) of the ABC to be bid. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II, Instruction of Bidders.

**Minimum Equipment Required:**

- 1 unit 1 bagger concrete mixer
- 1 unit bar cutter
- 1 unit cargo truck
- 1 unit centrifugal pump
- 1 unit backhoe

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulation (IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships or organization with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from NIA MOMARO IMO, Bids and Awards Committee at Barangay Bayanan II, Calapan City and inspect the Bidding Documents starting August 8, 2017 from 8:00 AM to 5:00 PM.
5. A complete set of Bidding Documents may be purchase by interest Bidders starting August 8, 2017 at the Office address above upon presentation of Letter of Intent (LOI), renewed PCAB License with "Small B" in irrigation and Flood Control-AIC Certificate of Registration, Certificate of Site Inspection issued by the Office of Division Manager (MOMARO IMO) and upon payment of non-refundable fee of Five Thousand (Php 5,000.00) pesos to the Cashier.
6. A Pre-Bid Conference will be held on August 16, 2017, 3:00 PM at the Conference Room at the office address above, which shall be open only to all interested parties who have purchased the Bidding Documents.
7. Bids must be delivered to the above office address on or before August 29, 2017, 3:00 PM. Bids will be opened on the same date at 10:01 AM at the NIA MOMARO IMO Conference Room. All bids must be accompanied by a bids security in any of the acceptable forms and in the amount stated in the ITB Clause 18.

Bids will be opened in the presence of the bidders (Managing Officer), no Special Power of Attorney (SPA), no Attorney-In-Fact Allowed to participate in the Bidding. Late bids shall not be accepted.

Bidder with negative 15% slippage of on-going projects will be automatically disqualified.

8. The NIA MOMARO IMO reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract of award, without thereby incurring any liabilities to the affected bidder or bidders, and not to award the contract if the funds/allotment for the project will be reduced/withheld or unforeseen event through no fault of NIA.
