II. Duties & Responsibilities:

- Prepare and recommend short and long-range plans and programs on O&M to sustain the efficient performance of existing irrigation system;
- Review and analyze annual budget for irrigation systems, periodic consolidated reports, repair and improvement as well as crop production and ISF reports;
- Supervise the O&M activities of existing irrigation system;
- Review and evaluate program target of field offices, sectioning of existing irrigation system and O&M performance of field offices;
- Develop plans and program to increase cropping intensity and formulate strategies for higher collection efficiency;
- Formulate and implement research activities to improve performance of existing irrigation system and collaborate with other research institution engaged in irrigated agriculture and irrigation development;
- Supervise and coordinate the implementation of efficient activities on O&M of completed restoration, repair and rehabilitation area and newly completed irrigation project;
- Coordinate and establish linkages with national and local government agencies and other agencies engaged;
- Establish monitoring and control system on the performance of existing irrigation system;
- Implement plans and program for the maximum utilization, assignment, transfer or movement of construction equipment and vehicles and the repair maintenance of equipment and design, preparation of specifications, acquisition, inspection, installation, operation and maintenance and repair of electro-mechanical and electronic equipment and structures;
- Evaluate periodic inspection and maintenance of construction equipment and vehicles and electro-mechanical and electronic equipment to prolong its useful life and ensure their operability to sustain operation and maintenance of irrigation systems;
- Evaluate major and minor repair of construction equipment and electro-mechanical and electronic equipment done in the irrigation offices and those undertaken by private entities to ensure quality of work;
- Review and evaluate the training design for the operators and maintenance personnel;
- Review and evaluate the proper type of equipment needed in the construction and rehabilitation of irrigation projects/systems;

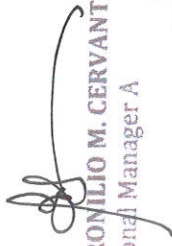
