### IV. ADJOURNMENT

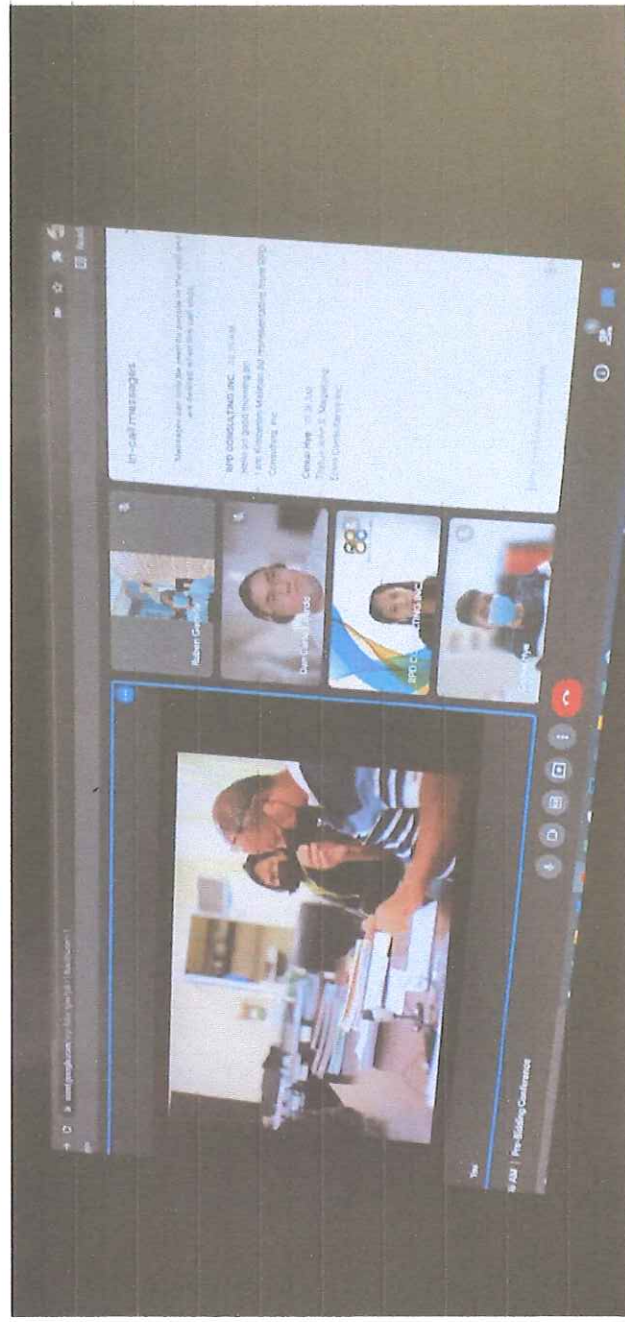
- For having no other matters to be discussed, the pre-bidding conference was adjourned at 11:00 A.M.

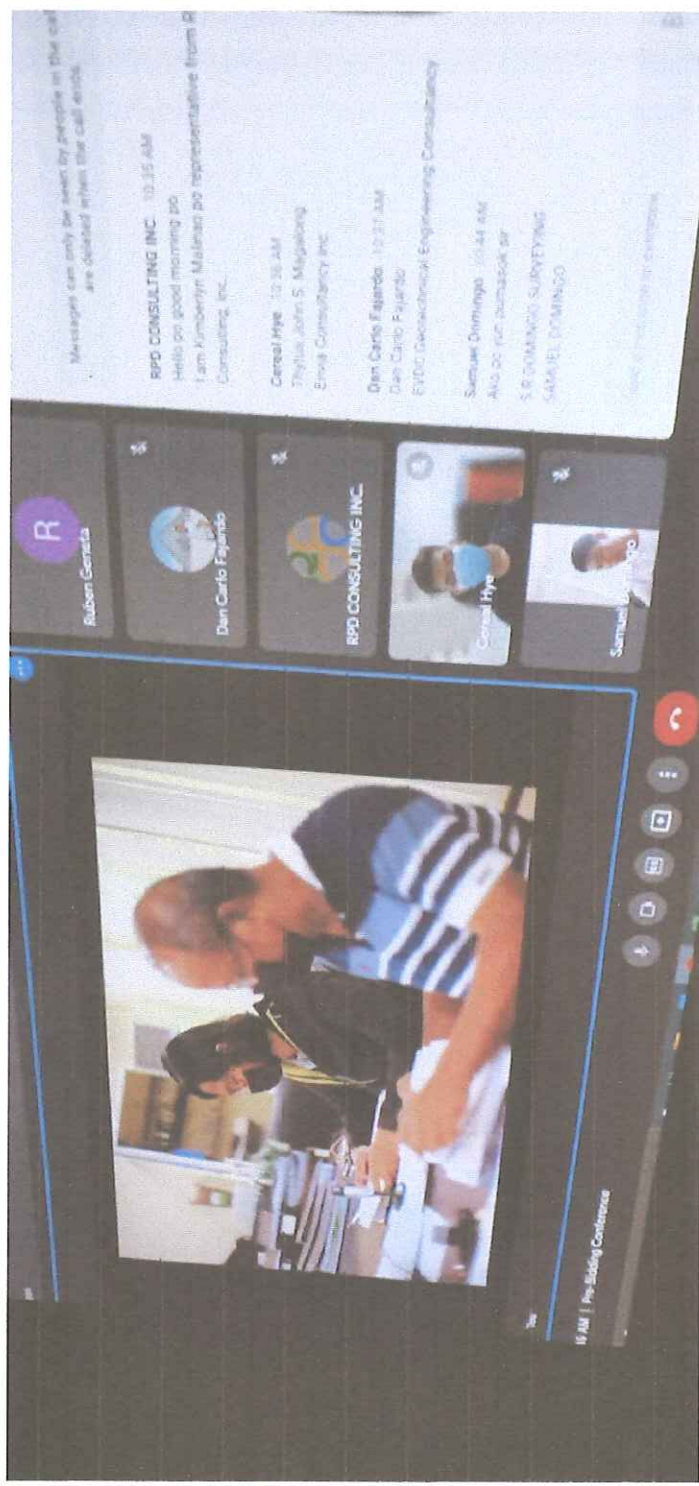
