 - f. Construction Safety and Health Program pursuant to DOLE Administrative Order No. 152 s. 2011
4. Contractor's All Risk Insurance (CARI)

All equipment and manpower must be available, taking into consideration other projects awarded to your organization which have the same or overlapping implementation periods.

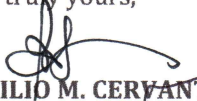
Failure to comply with these requirements shall constitute sufficient ground for the annulment of the award and forfeiture of the bid security.

Please be informed also that it is the responsibility of the contractor to strictly implement the requirements and procedures contained in the Republic Act No. 9184 and its Revised Implementing Rules and Regulations.

You are also required within the same ten (10) calendar days from the receipt of this notice to formally sign the contract agreement.

Please acknowledge receipt and acceptance of this notice by signing both copies in the space provided below. Keep one copy and return the other to NIA Regional Office.

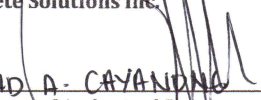
