CERVANTES**, with office address at Bayanan II, Calapan City, Oriental Mindoro (hereinafter called the "Entity") and **Wawao Builders**, represented by its Proprietor, **MR. MARK ALLAN V. AREVALO**, with office address at #25A Reynaldo St. Reyamar Subd., Tandang Sora, Quezon City (hereinafter called the "Contractor").



NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
