 - The TWG Member reminded the participating bidder that the personnel to be pledged for the project should be currently employed in their company.
 - TWG Member also reminded them that the contractors should not pledge an equipment that is already deployed/pledged on any of their on-going projects.
 - The TWG Head also said that the experiences of each required manpower should be included on their bio-data.
 - The TWG Member added that some of the personnel were required to have an NC II Certificate.
 - The TWG Member also reminded that their Certificate of Accomplishment to be attached in their bidding documents should tally with what is stated in their List of all On-going projects.

- Both of the participating bidders has no other questions and the reminders stated were clear.

IV. ADJOURNMENT

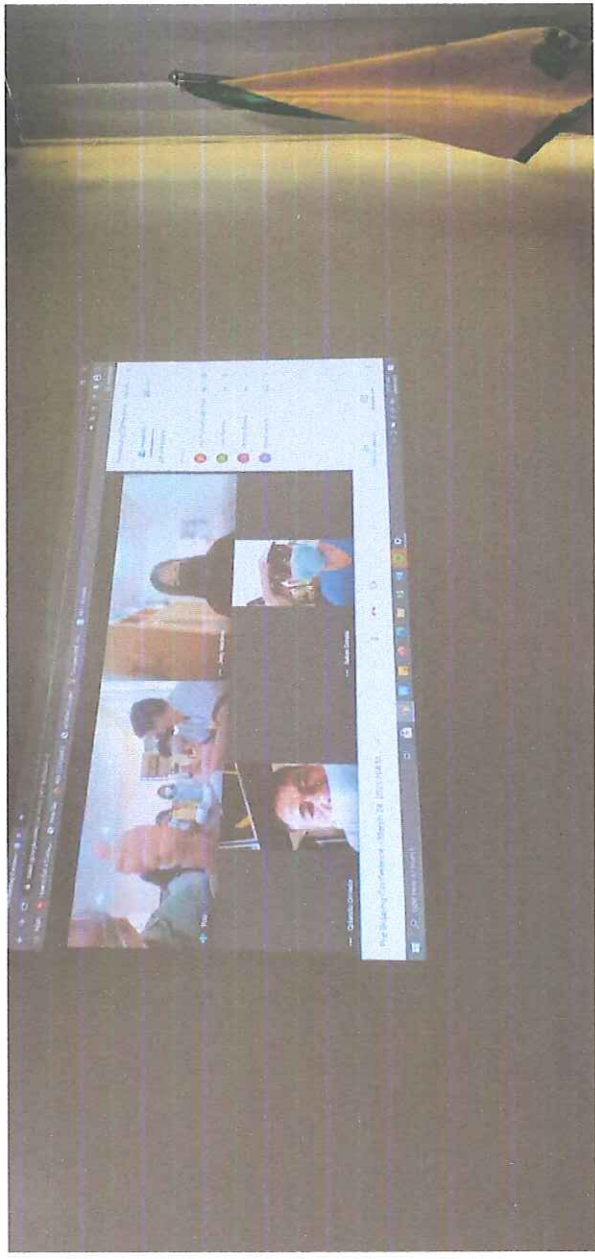
- For having no other matters to be discussed, the pre-bidding conference was adjourned at 1:45 P.M.
