

Contract Agreement

THIS AGREEMENT made this 12th day of April, 2019 between the **NATIONAL IRRIGATION ADMINISTRATION MIMAROPA REGIONAL OFFICE**, represented herein by the Regional Manager A, WILLIAM P. RAGODON, with office address at Bayanan II, Calapan City, Oriental Mindoro (hereinafter called "the Entity") of the one part and **MASANGKAY COMPUTER CENTER** represented by its Owner, PETER W. KO, with office address at 114G. Masangkay Street, Sta. Cruz, Manila (hereinafter called "the Supplier") of the other part.

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., SUPPLY AND DELIVERY OF IT EQUIPMENT, Lot 1 and Lot 2, with contract numbers LOT 1: R4B-RIO-ITEQPT-1.6M-CY18-11-LOT1 and LOT 2: R4B-RIO-ITEQPT-1.6M-CY18-11-LOT2, and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **ONE MILLION SIX HUNDRED FORTY FOUR THOUSAND NINE HUNDRED NINETY SIX PESOS (Php 1,644,996.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) the Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (*e.g.* bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the General Conditions of Contract;
 - (e) the Special Conditions of Contract;
 - (f) the Performance Security; and
 - (g) the Entity's Notice of Award.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract


